## Annexure

### Terms and Conditions:

1. The works to be carried out as per the specifications mentioned in the expression of interest (EOI) No: DDA/Kri.Bha/TO-1/EoI/polythene-3/2015-16
2. The Department of Agriculture, GOK shall have right to inspect the progress and quality of work at any time and can check based on parameters ,Quantity and quality of 300 Microns(type-1) Geo Membrane HDPE sheets
3. Agency shall give a warranty period of 3 years with warranty card for the HDPE sheet.
4. The fabric shall be uniform in colour, texture and finish shall be free from pin holes, un-dispersed raw material, particles or foreign material etc., The laminated sheet shall not peel off from the fabric.
5. The empanelled agency shall submit a sample piece of HDPE poly sheet of 1\*1ft quality with certificate to the concerned taluk and JDA office in all the talukas from where he would be getting work order.
6. The empanelled agency shall arrange for power supply on site at the time of sheet laying. the sheet laying should invariably be in the field itself. The empanelled EOI agency is responsible for getting all the required equipments in the field.
7. The empanelled agency shall undertake to train the farmers on care and maintenance of lining material after sheet laying.
8. The empanelled agency shall have to provide service after sheet laying to the farmer at free of cost for any natural damage for 3 years and extend after warranty for reasonable and affordable price to the farmers as negotiated and fixed by the department of agriculture
9. District joint directors/Department of Agriculture shall have the right to collect random samples for the quality tests as per BIS standards, in the event of any materials failing to confirm to the standards on quality, the District Joint Directors have the right to reject the material and the empanelled EOI applicants shall replace the rejected materials with fresh stock at their own cost within the specified time given by the department.
10. For hydrostatic resistance test, test specimen shall be selected such that atleast one joint is covered.
11. The empanelled EOI applicant should ensure availability necessary spare parts available by keeping necessary stock of such material.
12. The empanelled EOI applicant should complete the work within 15 days from the date of receipt of letter from farmer/Department for work.

13. The empanelled EOI applicants shall be liable for black listing and penalties, if he fails to comply the above conditions.
14. For any casualty/injury/death occurred at the time of execution of work, it is the sole responsibility of the firm/company executing the work.
15. payment will be made through the farmer.
16. The L1 rates quoted would be valid for a period of at least one year of acceptance from the date of executing the agreement.
17. The department will not entertain any price revision during the validity period of EOI or extended period thereof.
18. if any information provided by the empanelled agency found factually false or misleading, such empanelled agency will be removed, with out any notice, at any time during the validity of the EOI and also liable for penalties as applicable.
19. If any agency is black listed by any state or agency, such empanelled agency are liable for rejection at any time during the validity of the EOI.
20. The empanelled EOI applicants should not indulge in sub contracting the execution of work.
21. The bill should be in the name of empanelled agency only.
22. Farmers would have the choice to select the agency out of the empanelled list of agencies.
23. In respect of any dispute arising out of implementation of this EOI the decision of the Commissioner of Agriculture who is the EOI ACCEPTING AUTHORITY shall be final.
24. Any disputes or difference arising out of or in connection with the contract order shall be to the extent possible settled amicably between the parties. If amicable settlement cannot be reached, then all disputed issues shall be settled by arbitration.
25. Jurisdiction: the courts of Bangalore only shall have jurisdiction to deal with and decide any legal or dispute arising out of this contract.
26. All other conditions as per EOI are applicable.
